OVERVIEW

In a comparable criminal case, the below outlined misconduct by *#NJJudgeThomasMMoore*, would result in a mistrial, at a minimal. In this instance, *#NJJudgeThomasMMoore's* Orders

dated July 24, 2017, December 1, 2017, January 5, 2018, and February 2, 2018 should be voided/vacated/remanded. And **#NJJudgeThomasMMoore** should be sanctioned or removed !

The Bottom Line just outcome would halt the July 16, 2019 Eviction from my Vailsburg, #NewJerseyUNIQUE home of more than 30 years. Moreover, in the best of times, you Gentlemen would declare a **STATEWIDE MORATORIUM** on **ALL #FRAUDclosure**, auctions, and evictions, while resuming the 2010-13 review.

BODY OF MY COMPLAINT

#NJJudgeThomasMMoore is a contributing factor in how and why **#NewJerseyUNIQUE** remains #1 in **#FRAUDclosure** 2019, 2018, 2017, 2016, 2015, and counting.

#NJJudgeThomasMMoore and my paths crossed when I appeared before him numerous times starting in 2014. Although **#NJJudgeThomasMMoore** almost always ruled against me, I accepted such decisions as the presumed *fait accompli* for a **#HurtingHomeOwner**. That was my mindset until July/August 2017. At that juncture **#NJJudgeThomasMMoore** weighed his heavy thumb on the scale of justice. **#FRAUDclosure** is traumatizing enough without Judicial Pile-On !

#NJJudgeThomasMMoore's chronology of misconduct is outlined in the attached copy of my New Jersey Appellate Motion To Reconsider the panel's June 17, 2019 decision.

#NJJudgeThomasMMoore's duplicity is well documented in the referenced Court Transcripts of my January 5, 2018 and February 2, 2018 hearings. To sum up my Disciplinary Complaint, **#NJJudgeThomasMMoore** callously, deliberately, knowingly, and intentionally delayed a crucial hearing in my case for **3 MONTHS**.

I hesitantly, but instinctively add this vivid recollection from my **#FRAUDclosure** sojourn with **#NJJudgeThomasMMoore**. During the first few minutes of the July 21, 2017 hearing, I clearly remember **#NJJudgeThomasMMoore** uttering this cryptic remark: "Now Mrs. Bailey, you know this has gone on long enough." I was taken aback, but shrugged and chalked up **#NJJudgeThomasMMoore**'s presumption and bias to "everyone is entitled to his own opinion". Never in my wildest imagination did I expect **#NJJudgeThomasMMoore** to act out his proclivity by greasing the skids, i.e. a strategic **3 MONTH DELAY**.

Now that takes **CHUTZPAH !!!**

#NJJudgeThomasMMoore's succinct "*long enough*" statement has long since vanished from the CD audio recording of that July 21, 2017 hearing. We are now left with: "*You just have to take my word for it*". Such misconduct is an outrage and must be denounced by those with the authority and power to address the harm done.

That heinous and calculating act turns *#NJJudgeThomasMMoore* into an accessory to my *#FinancialMURDER*.

As things now stand, by the time my Appeal process winds through the New Jersey Court System, I will have been evicted from my home of over 30 years for as long as two years ! Any and all of my valid arguments will be deemed as rendered "*moot*".

Maybe, just maybe, that's the way an *#InJusticeSystem* is supposed to work against a *#HurtingHomeOwner*.
