- 2) Read the [KShaped Recovery Black Paper](#).
- 3) Write out your #FRAUDclosure ordeal, from Default Notice to Sheriff Eviction !
Be sure to include suspicious/fraudulent actions on the part of the #PredatoryBANK/Loan Servicer.

- 4) Prepare, or ask someone to prepare, the typed version, adhering to the format outlined on the following pages.

THE FINAL VERSION OF YOUR LETTER SHOULD NOT BE LONGER THAN 6 PAGES, INCLUDING THE COVER SHEET. TRY TO CONDENSE IT TO 4 PAGES.

- 5) You will greatly assist your efforts for remediation by providing a copy of the letter you send to Senator Harris, to the suggested local officials and other leaders. To locate the correct mailing address for your local officials, please click on -- <https://www.usa.gov/elected-officials>
