There is a treasure trove of RMBS RICO #DEEP6FRAUDclosure evidence stored on 40 hard drives and in 12,700± cubic feet of warehouse space. (700 cubic feet of docs were recently moved. By whom, to where, & why, are open questions.) But time is of the essence. If bankrupt #FRAUDclosureMill Zucker Goldberg has its way, the stored docs dating back as far as 1995,

will soon be shredded, and the hard drives will be left under the “safe keeping” of Zucker Goldberg’s related money-making side, 4s Technology LLC. Michael S. Ackerman, Esq. is the manager of both entities. [Info shared at December 4, 2015 hearing and in related filed docs.]
